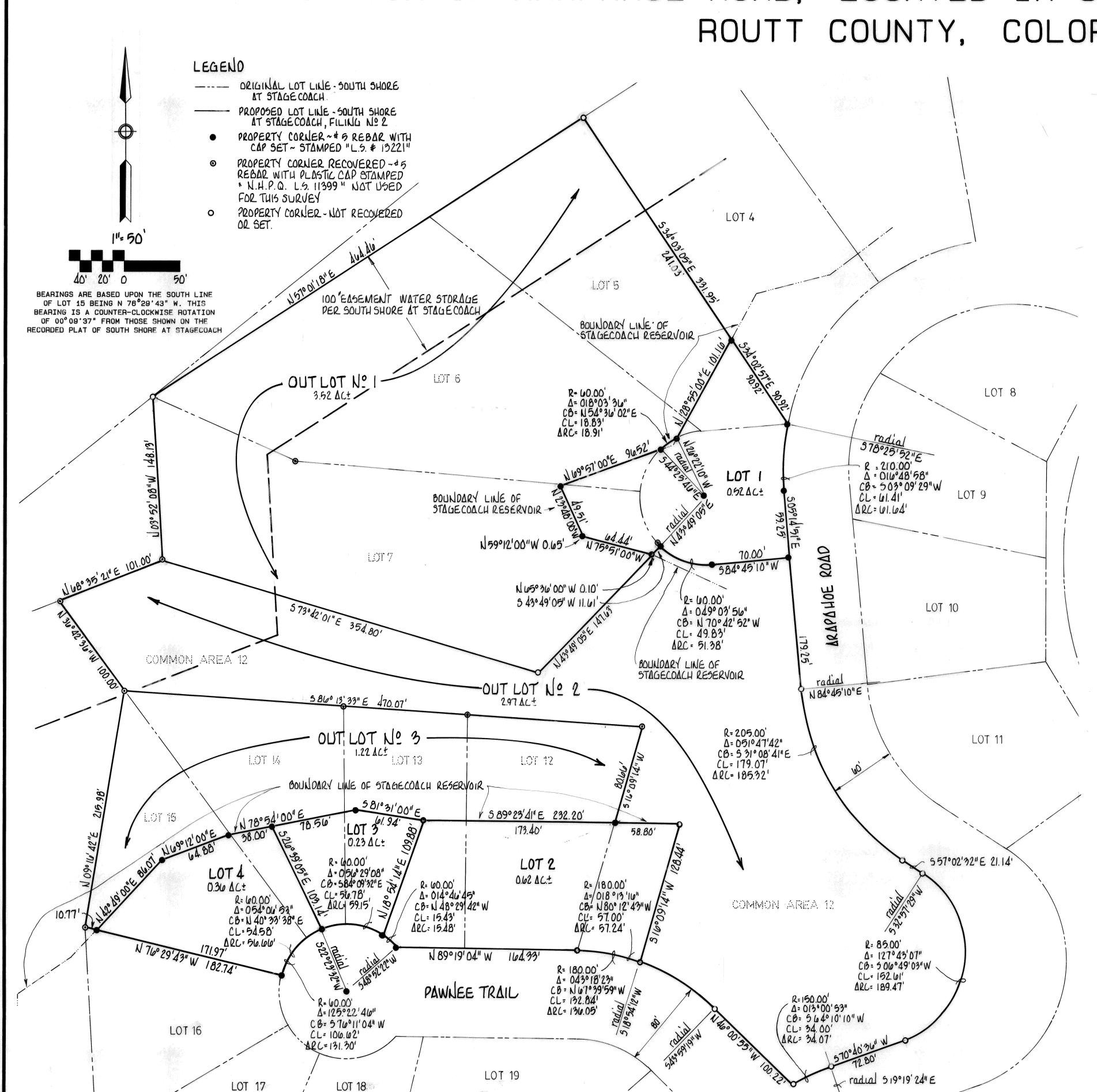
SOUTH SHORE at STAGECOACH, FILING No. 2

I, Robert Weiss, an Attorney-at-Law duly licensed to practice before the Courts of Record in the State of Colorado, do hereby certify that, based upon the "Commitment for Title Insurance" prepared by Transamerica Title Insurance Company, policy numbers 7810297 C, 7811889 C and 7811890 C, dated December 5, 1985, November 18, 1986 and November 18, 1986 respectively, I have examined the record title to all lands herein dedicated and shown upon this plat and that title to such lands is in the dedicator free and clear of all liens, taxes, and encumbrances, except as follows:

(1) reservations, restrictions, agreements, covenents and easements of record or apparent (2) interest of third parties in any portion of the dedicated property created by virtue of recorded covenants or the provisions contained on the South Shore at Stagecoach Plat, and (3) all matters set forth in the standard printed exceptions contained in such Commitments.

Easements as Dedicated are situated inside all lots, unless otherwise shown, as follows:

10 foot wide utility and drainage easement for the installation and maintenance of public utilities and for drainage purposes on all lot lines.

10 foot wide trail easement on all side lot lines, being lot lines between lots or outlots.

20 foot wide trail easement on all back lot lines and boundary lines, being lot lines not fronting on roadways or another lot. State of Colorado
